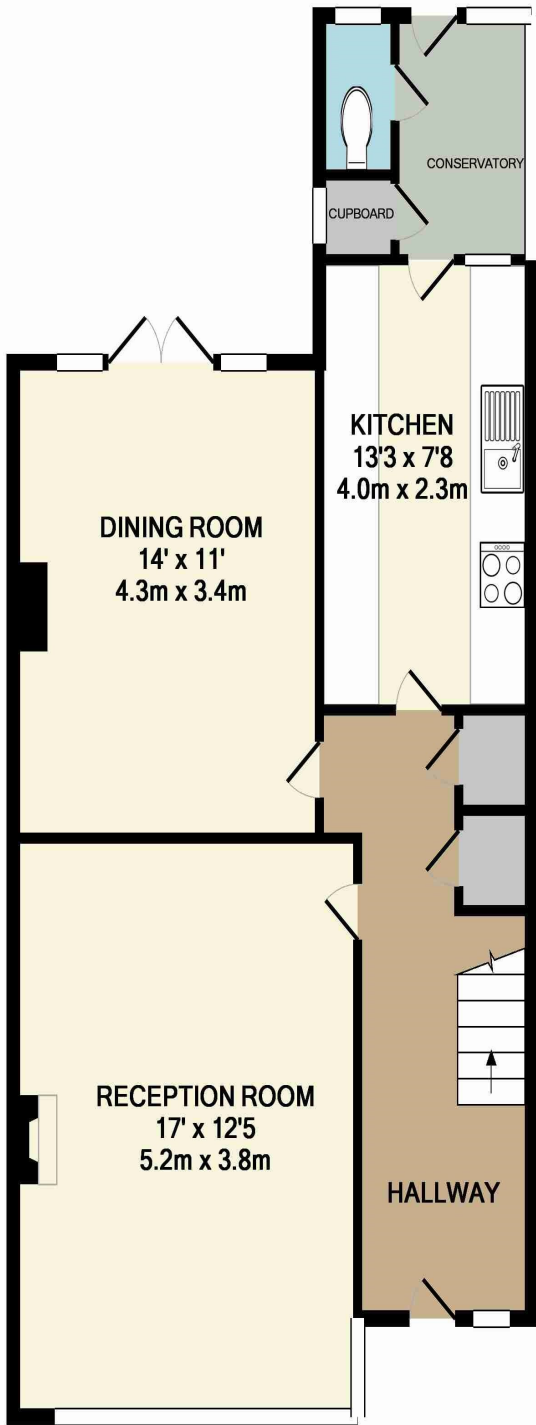

The entrance hall comprises of two reception rooms, kitchen, W.C in lean to.

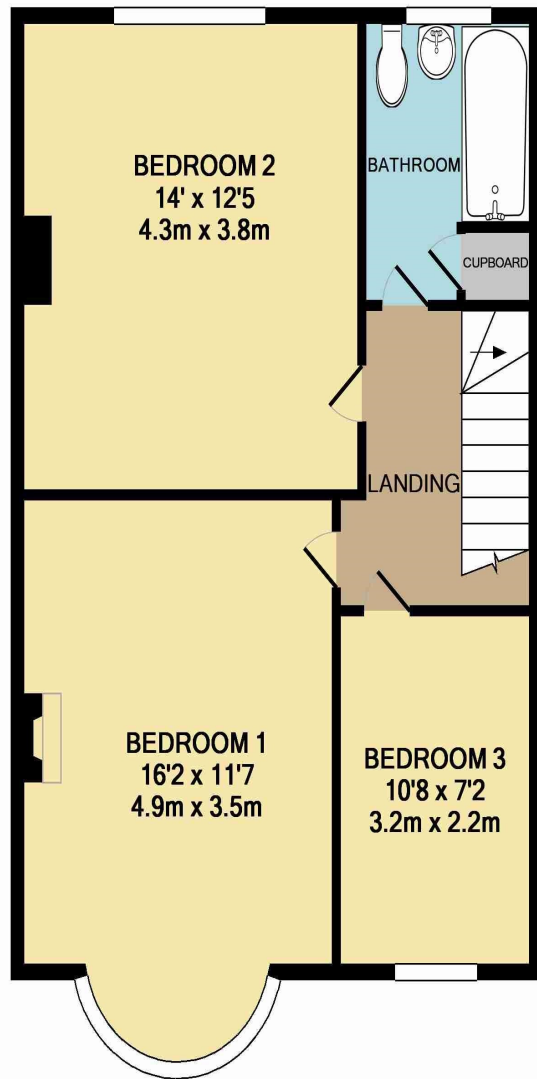
The first floor comprises three bedrooms and a bathroom.

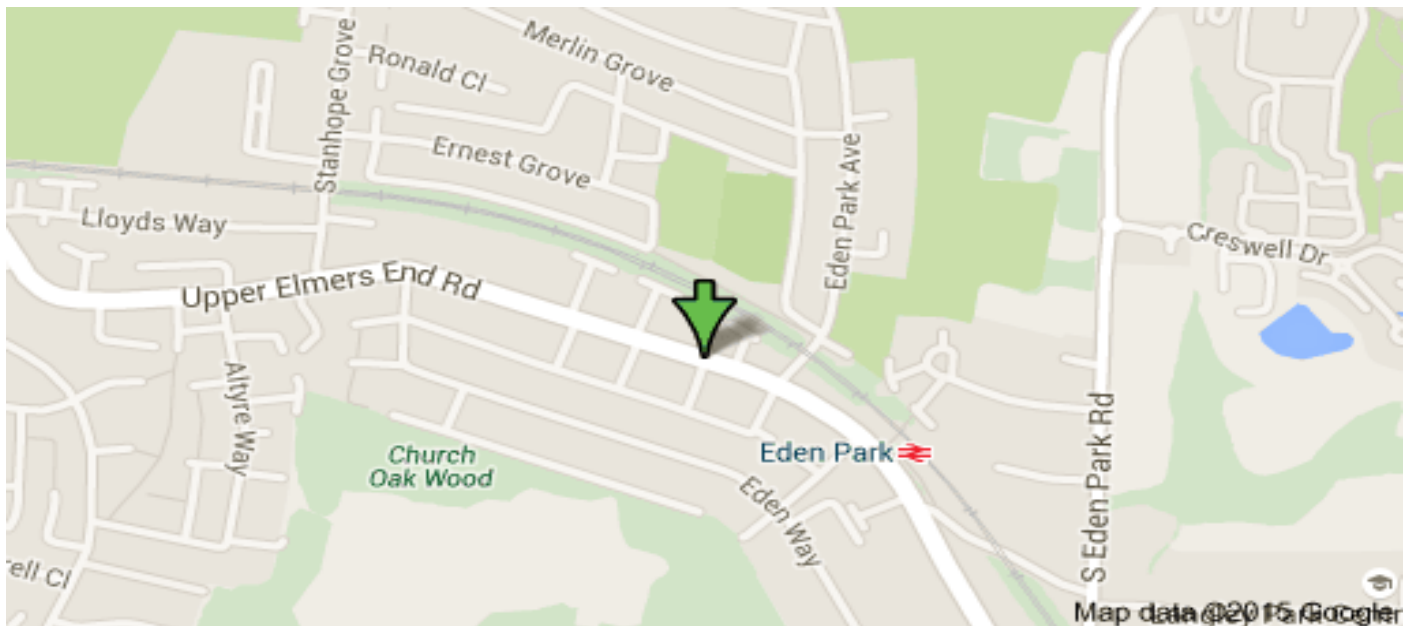
